Rita Teaotia - Additional Secretary, Department of Electronics & IT, Government of India Smt. Rita Teaotia joined the Indian Administrative Service in the year 1981. DeitY has also taken initiatives to prescribe Standards and Policy Guidelines, provide technical support, undertake R& D and Capacity Building to support successful implementation of various national eGovernance Projects. NeGP works closely with all arms of DeitY including, National Informatics Centre (NIC), Standardisation Testing and Quality Certification (STQC) Directorate, Centre for Development of Advance Computing (C-DAC) and National Institute for Smart Governance (NISG).

Dorothy K. Gordon - Chair, E-Governance Commission, WITFOR

Dorothy K. Gordon is a visionary leader in the field of technology and development. In her capacity as the Director-General of Ghana's Advanced Information Technology Institute, the Ghana-India Kofi Annan Centre of Excellence in ICT (AITI-KACE), she leads a team of world-class technology professionals committed to using the opportunities that exist globally to bring development to Africa. She is currently a Board member of Film Africa – a production company which, along with its sister company, TV Africa, is dedicated to promoting African culture and values.

Dorothy Gordon is Chair of the Commission on E-Government for the World IT Forum (WIT-FOR); President of the Ipv6 Forum Ghana; Board member and Africa Spokesperson for the World Summit Awards; and Director, UNESCO International Institute for Capacity Building in Africa (IICBA).

She joined the United Nations Development Programme (UNDP) after obtaining degrees from the University of Ghana and the Institute of Development Studies (IDS) of the University of Sussex, UK.

Her career as a specialist in international development spans over 25 years with increasing leadership and management responsibilities.

Ajay Sawhney - Co-Chair, E-Governance Commission, WITFOR

An Engineer by qualification, an IAS officer by profession and a champion of Information Technology by choice, Ajay Sawhney is an experienced Technocrat Administrator.

Mr Sawhney is currently working as the President and CEO, National eGovernance Division, Media Lab Asia, Department of Electronics & IT (DeiTY), Government of India. The National eGovernance Division assists the DeiTY in Programme Management of the National eGovernance Plan, framing of core policies, design of shared service delivery platforms, technical appraisal of all NeGP projects and various capacity building initiatives, including the setting up of State eGovernance Mission Teams.

Commencing his career in the Indian Administrative Service in the Andhra Pradesh cadre in 1984, Mr. Sawhney played a key role in the success of the Total Literacy Campaign in the district of Nizamabad. Appointed as Managing Director of A.P. Technology Services Limited in 1995, he became a strong advocate of technology and led a programme for computerisation of data pertaining to more than 45 million voters. As Special Officer for International Institute of Information Technology (IIIT), Hyderabad, he was responsible for shaping the conceptual model, setting up the Institute in 1998 and catalysing its emergence as a pre-eminent institute in IT Education & Research. From 1999 to 2005, he was involved in the development of the IT vision, architecture and e-Government projects of Andhra Pradesh as Secretary, Information Technology.

Vikas Nath - Chair, Agriculture Commission, WITFOR

Vikas Nath is the Associate Director of the Future of the United Nations Development Systems (FUNDS) project and the Chair of WITFOR Agriculture Commission.

His previous position was as Head - Media and Communication, South Centre, a Geneva-based intergovernmental organisation. Prior to it, Mr. Nath worked as a Policy Analyst with the United Nations Development Programme (UNDP) in New York where he carried out research on provisioning and financing of global public goods, including the Internet and the Global Communications Network. Mr. Nath also worked with the Ministry of Environment and Forests, Government of India, as a Training Adviser on Agenda 21 and Environment and Sustainable Development issues.

Mr. Nath is the founder of multiple companies and initiatives, including DigitalGovernance.org, DevNetJobs.org, and Intellectual Network of the South (INSouth.org). He has worked with UN agencies, international and national organisations in over 50 countries on e-governance, South-South cooperation, and applications of information technology in agriculture, setting up small and medium enterprises, and employment generation.

Mr. Nath was an Inlaks Scholar (2000-1) at the London School of Economics and Political Science (LSE), UK. He holds a Masters degree in Environment and Development from the LSE and in Natural Resources Management from the Indian Institute of Forest Management (India). www.VikasNath.org

Sanjeev Gupta - Co-Chair, Agriculture Commission, WITFOR

Sanjeev Gupta is a 1985-batch Indian Administrative Service (IAS) officer from the Himachal Pradesh

cadre, where he had been actively involved in various e-governance initiatives in the state – including the implementation of the voters ID card project – before moving to the Ministry of Agriculture as a Joint Secretary in the Government of India. He is credited with implementing the first State Wide Area Network (SWAN) project in India under the National e-Governance Plan (NeGP). Before taking over as the IT Secretary with the state government in 2003, he had served as the Additional Secretary and Special Secretary with the Himachal Pradesh Computer Society. An Electronics graduate from IIT Kanpur, he is also credited with turning around the fortunes of the HP State Electronics Development Corporation as its MD and creating benchmarks for the procurement of electronic products for the state government.

Alain Senteni - Chair, Education Commission, WITFOR

Professor Alain Senteni is currently the Dean of the School of e-Education (SEED) at the Hamadan Bin Mohammed e-University in Dubai (UAE). From 2001 to 2008, Prof Senteni was the (first appointed) Director of the Virtual Centre for Innovative Learning Technologies (VCILT) and the Chairman of the Lifelong Learning Cluster (LLC) of the University of Mauritius. He received an Engineering Degree, a PhD and HDR in Computer Science from the National Polytechnics Institute (INPT) in Toulouse (France).

His interest in technology-enhanced education dates back to the 1970s, with the Logo community in Montreal (Qc. Canada) where he was appointed as a Professor in Educational Technologies at the Faculty of Education of the University of Montreal from 1989 to 1996. His current work and research interests lie in the integration of ICTs in the educational systems of developing countries, with an emphasis on intervention strategies, capacity building and ICT-based development of education. In September 2011, he received an Honorary Doctorate in Education from the University of Sherbrooke in Canada.

Radha Chauhan - Co-Chair, Education Commission, WITFOR

Ms Radha S. Chauhan is a 1988 batch Indian Administrative Services (IAS) officer from the state of Uttar Pradesh. She is currently serving as the Joint Secretary of School Education and Literacy in the Human Resource Development Ministry in the Government of India. A Law graduate from Delhi University's Faculty of Law, she has previously served with the National Institute for Smart Government (NISG) as a Principal Consultant to the Programme Management Unit of the National e-Governance Plan (NeGP), Department of IT, Government of India.

She has coordinated two national Mission Mode Projects under the NeGP - the 'e-district' Project and the Unique ID project, both of which attempt to address key aspects in the delivery of government services to citizens in an electronic mode. She has also steered the National Communication and Awareness strategy for the overall NeGP initiative and has had a long association with the post-implementation assessment of e-Governance initiatives across the country.

Paul T. Nleya - Co-Chair, Education Commission, WITFOR

Paul T. Nleya earned a B Ed degree from the University of Botswana in 1981 and an MS in Instructional Systems Technology in 1985 from Indiana University (Bloomington) in 1985. He also earned a PhD in Educational Technology and Post Graduate Diploma in Social Science Research Methods from the University of Wales (Cardiff). He is currently Associate Professor and Head of the Educational Technology Department at the University of Botswana. He has been published in refereed journals, both local

and international. He serves as the Vice-Chair of the Education Commission of the World Information Technology Forum (WITFOR) and holds a membership of the Working Group 3.3 of the International Federation of Information Processing (IFIP WG 3.3), and is on the Advisory Board of eLearning Africa Conference (eLA). He is also a member of the Association of Educational Communication and Technology (AECT) and Multimedia Educational Resource for Learning and Online Teaching (MERLOT).

During 2008, he served as coordinator of an online program development assignment for e-TOM College in Dubai. He is also External Examiner for North Western University and Tshwana University of Technology in the Republic in South Africa and has served as Chairperson of the Reference Committee of the Open and Distance Learning national needs assessment conducted by the University of Botswana during 2008.

Jørn Braa - Chair, Health Commission, WITFOR

Jørn Braa is Associate Professor at the Department of Informatics, University of Oslo, as well as the Coordinator of the Health Information Systems Program (HISP) and the Building Europe Africa collaborative Network for applying ICT in Healthcare Sector (BEANISH). Jørn Braa has been involved in Health Information Systems research and development in many countries in Africa, Asia and Latin America over the last 15 years. He has been actively involved in the establishment and expansion of the HISP project for 10 years. His research interests focus on strategies and conditions for action research, and health information systems in developing countries.

Sundeep Sahay - Co-Chair, Health Commission, WITFOR

The focus of Sundeep Sahay's work, pursued in external projects and published academically, has been on the design, development, integration, use and sustainability of health information architectures in developing countries, with a primary focus on the Indian public health system. Further, his focus is on creating organisational models, which can provide technical support in the Indian context and South East Asia.

Sundeep Sahay's academic work is characterised by an empirically-grounded approach, primarily within an action research framework - working closely with public health managers, policy makers, health programme managers and field-level health functionaries. He has extensive experience with management of research projects involving partners from universities, the public health sector, and also running an NGO.

His research agenda has, for more than a decade, had a sustained focus on the theoretical, methodological and practical implications of large-scale and integrated health information architectures. Prior to this, a key research focus had been on Global Software Outsourcing. Taken together, the collective research focus is on IT for Development.

Ana Pont - Chair, Building Infrastructure Commission, WITFOR

Dr. Ana Pont Sanjuán is Professor of Computer Architecture in the Polytechnic University of Valencia (UPV), Spain. She joined the Computer Engineering Department (www.disca.upv.es) at the UPV in 1987, and from 1998 until 2004 she was the head of the Computer Science High School at the UPV. Her research interests include web and internet architecture, proxy caching techniques, CDNs, communication networks and performance evaluation. She also has participated in a large number of research projects financed by the Government of Spain and the Local Valencian Government. Currently she leads the Web Architecture Research group at the UPV where she has been advisor of several PhD theses and is currently directly tutoring two more.

She has published a number of papers in international journals and conferences proceedings, some of which have been awarded as the best papers. She often acts as a reviewer for several journals and regularly participates in the technical programme committees of international scientific conferences.

From 2005 to 2011, she was the Chairperson of the IFIP TC6 Working Group 6.9: Communication Systems for Developing Countries (www.ifip.tu-graz.ac.at/TC6/index.htm). Now she is the Spanish representative in IFIP - Technical Committee 6.

She joined the WITFOR series in 2007 as co-chair of the Building Infrastructure Commission.

Robert Argent - Chair, Environment Commission, WITFOR

Dr Argent is currently with the Bureau of Meteorology in Australia and has over twenty years of international experience in water and natural resources research, teaching, design, consulting and project management. Over the period from 1990 to 2007, he worked at the University of Melbourne, focusing on environmental model development and integration. His research interpreted and delivered environmental research findings into forms that met the needs of managers and decision makers.

In early 2008, Robert moved to the Bureau of Meteorology to lead the development of the Australian Water Resources Information System (AWRIS), the world's first system that will offer end-to-end coverage of Australia's key water data. It will cover the entire gamut of the ingestion of data from across the country, through data checking and augmentation, extensive analysis and reporting, and delivery of data and information to end users.

David Swayne - Vice-Chair, Environment Commission, WITFOR

Professor David AB (Dave) Swayne is a retired Professor from the University of Guelph (Canada). He is a Fellow of the International Environmental Modelling and Software Society, and a recipient of the Silver Core Award from IFIP. His research concentrates on the application of computing to environmental problems, using decision theoretical principles and graphical probability models, linking economic and engineering process models.

Collaborative work with government and industry has led to working environmental information systems at many levels: regional climate change modeling in the Arctic Great Lakes; acid rain in North America; water pollution in the Great Lakes Basin, decision support in urban water districts; river basins in Mexico, Central and South America, and Australia. Prototype systems have been developed for pulp mill effluent, ocean dumping, acid mine effluent, and Sustainable Community Indicators. Dr. Swayne is an Associate Editor of the journal *Environmental Modelling and Software*, Vice-President of the International Environmental Modelling and Software Society and a past Chair of International Federation for Information Processing Working Group 5.11 (Computers and Environment).

Mr. Satish Jha - Chair, Economic Opportunities Commission, WITFOR

Satish Jha is the Chairman of OLPC India Foundation with a mandate to reach out to 250 million chil-

dren who are growing up without access to computing. Satish has worked as a newspaper editor (Editor, Dinamaan, The Times Group, and co-founder, Janasatta, The Indian Express Group); as Global Head of Information Technology Management for VFC Division at Hoffmann-La Roche; and founded James Martin & Co and META Group in India. He is also actively engaged with a number of social initiatives and has founded, mentored and/or seeded various projects and initiatives.

He co-founded Tarahaat.com, DESI Power, Digital Partners India, Baramati Initiatives, and eHealth-Care Initiatives and has been associated with leading various social entrepreneurship initiatives across Africa and Asia. He has lately been focusing on the intersection of technology, business strategies and public policy in the areas of universal access to education, healthcare and bridging the digital divide. He is also a member of the United Nations' GAID, Special Advisor to the Kofi Annan Center and chairs the Economic Opportunities Commission for the World IT Forum (WITFOR).

Satish studied at The Fletcher School of Law & Diplomacy, Kennedy School of Government; University of Maryland; EDHEC-Institute Theseus in France, and the Institute of Social Studies at The Hague and earned an MA in Economics and an MBA in Strategy, Innovation and Information Technologies. He has also been a National Scholar in India, a Hubert Humphrey Fellow, Ford Fellow, and Netherlands Fellow and was granted scholarships for management education by France Telecom and BNP.

DISTINGUISHED SPEAKERS

Minister Hugo Royg Aranda

Minister Hugo Royg Aranda was born in Asuncion in March 1967. He graduated as an Economist at the Catholic University of Asuncion and completed his academic studies in Macroeconomics and Public Policy at various institutions in Paraguay and abroad.

Currently, he is the Executive Secretary of the Ministry of Technical Planning for Economic and Social Development under the Presidency of the Republic of Paraguay. Previously he served as Technical Coordinator of the Technical Unit of the Social Cabinet of the Presidency of the Republic.

He has served as a Consultant to Multilateral Agencies of international cooperation on public policy issues as well as on poverty and human development. He is a member of several social organisations and teaches at undergraduate and postgraduate level at the National University and the Catholic University of Asuncion.

His work in the private sector places him as the founder of MCS Consulting Group with extensive experience in advising private companies in areas of change and organisational development.

Janis Karklins

Mr. Janis Karklins is the Assistant Director-General for UNESCO's Communication and Information Sector. Having served as the Latvian Ambassador to France and Permanent Delegate to UNESCO after an initial career in industry - Mr Karklins became the Permanent Representative of his country at the United Nations in Geneva, a post he held for seven years. During that time, he served as the First Vice-Chairman and as Chairman of the Council of the International Organization for Migration (IOM), and has held several elected posts in the World Intellectual Property Organization (WIPO) and UN Commission of Science and Technology for Development, as well as presided over the Group of Governmental Experts on Cluster Munitions in the framework of the Convention on Certain Conventional Weapons (CCW).

He also served as the Vice-President of the Preparatory Committee of the Geneva Phase of the World Summit on the Information Society (WSIS) and as President of the Preparatory Committee of the Tunis Phase of WSIS. As a diplomat, he was closely involved in the preparation of the World Summit on the Information Society (WSIS) and played a key role in its negotiations on internet governance. In 2006, Mr Karklins was elected president of the Government Advisory Committee of ICANN (Internet Corporation of assigned Names and Numbers), which plays a pivotal role in information society issues. He was appointed to the ICANN Board of Directors in March 2007, and at the same time assumed the post of Chairman of the Governmental Advisory Committee (GAC) and liaison from the GAC to the ICANN Board.

Mr Karklins has an engineering degree from the Riga Technical University in Latvia and attended an executive education program for Eastern European diplomats at the Hoover Institute at Stanford University in USA.

Leon Strous

Leon Strous is the President of the International Federation for Information Processing (IFIP) since 2010. Leon is a member of the International Federation for Information Processing (IFIP) since 1994. In IFIP he has chaired the Technical Committee 11 on security and protection in information processing from 2001-2007, he was Vice-president from 2007-2009 and in August 2009, he was honourably elected as President for the 2010-2013 term.

Leon started his career in metal and plastics processing and then spent eight years with the sales organisation of Philips Electronics in the Netherlands. His focus areas were administrative organisation, internal control and information security. Currently his main jobs are advancing business continuity and crisis management arrangements with the key players in the payments and securities clearing and settlement processes in the Netherlands and liaising between the financial sector and the government concerning critical infrastructure protection programs.

Leon has co-authored and co-edited publications in the area of information security and chaired /organised several international security conferences. Since 2001, his contributions include work with the IFIP World IT Forum (WITFOR), a conference focusing on the application of ICT in developing countries.

Leon has bachelor equivalent degrees in Business Economics and Business Informatics, a post-graduate degree in EDP-Audit; he is qualified as a registered EDP-Auditor (RE) in the Dutch Association of Registered EDP-Auditors (NOREA) and he is also a Certified Information Systems Auditor (CISA).

K.K. Aggarwal

Professor K.K. Aggarwal, Chancellor- Lingaya's University, Faridabad, also serves as Chairman, Board of Governors, Malaviya National Institute of Technology, Jaipur and Member, Board of Directors, Indian Institute of Technology, Patna.

He obtained his Engineering Degree from Punjab University and Masters degree from Kurukshetra University, from where he did his Ph.D in Reliability Evaluation and Optimisation. After having served at NIT, Kurukshetra, he was appointed Pro Vice-Chancellor, Guru Jambheshwar University (Technical University of Haryana), Hisar for a period of three years. In 1998, he was appointed as Founder Vice Chancellor of GGS Indraprastha University, Delhi and continued at this position for 10 years.

He was President of the Institution of Electronics and Telecommunication Engineers (IETE) from 2002-2004. He also served as Sectional President (IT & CS Section) in the Indian Science Congress Association. He was elected as President, Computer Society of India for the period 2007-2009. Prof. Aggarwal was also elected as President of South East Asia Regional Computer Confederation (SEARCC) for 2008-2010.

Prof. Aggarwal has worked extensively in various fields of Electronics and Computer Engineering and published about 300 papers in reputed journals, including more than 130 in international journals. He has been invited to deliver lectures in several Universities in India and abroad. Prof. Aggarwal has written a few books and many of his articles have appeared in several books published by IEEE of the USA. His latest book on Software Engineering, published in 2001 has already seen several reprints.

He was conferred the Life Time Achievement Award by the Institute of Electronics and Tele-Communication Engineers.
